

What is A Safe Place to take a baby?

A Safe Place for Newborns is a:

- » *Hospital*
- » *Doctor's Office*
- » *Birthing Clinic*
- » *Police Station*
- » *Sheriff Office*
- » *Fire Department*

Who do I leave the baby with?

Leave the baby with a staff person at any of the places listed above. Remember you must give the baby to a person who works at the facility.

What's next?

- » *You are free to leave at any time.*
- » *If you need support or to talk to someone about this decision call:*

Remember, if you follow the steps above, and the baby has not been abused, you will not face any legal consequences for making this choice.

When a parent cannot care for an infant, leaving the baby at A Safe Place for Newborns may be the best choice for the child. If the birth parent is not sure about this decision, an adoption social worker can help by providing information on available options and services for birth parents and their babies.

Not all women who get pregnant are ready to raise a child. Sometimes they see no alternative except to abandon the baby.

This is a big decision. Please tell someone you trust that you are pregnant.

Because the health and safety of children and parents is important:

- » *Tell a trusted person about the pregnancy.*
- » *Find out about adoption.*
- » *If you can't do one of the above, then ensure the baby is left at A Safe Place for Newborns location.*

How does the “A Safe Place for Newborns” law work?

Either parent can take the baby to a:

- » *Hospital*
- » *Doctor's Office*
- » *Birthing Clinic*
- » *Police Station*
- » *Sheriff Office*
- » *Fire Department*

As long as the baby:

- » *is 30 days old or younger,*
 - » *is handed to a person at one of the above places,*
 - » *shows no signs of abuse,*
- There will be no legal consequences for making this choice.*

Do I have to call ahead?

No. A parent may take a baby to A Safe Place for Newborns at any time until the child is 30 days old.

Will I have to provide any information?

No identifying questions will be asked, however, it would help the baby if you choose to provide basic health information.

You will be offered a form to give health information. You can fill out the form immediately or you can take it with you to fill out and send in later.

What happens next?

The baby will be cared for and will get medical attention if needed.

Community Human Services Child Welfare will place the baby in foster care and start the legal process. There are many families who want to adopt a baby.

What happens if I change my mind?

If you change your mind, you can seek custody of the baby. A court hearing will be held on the first business day after the day the baby is left. There will be several court hearings after that date. Your ability to seek custody of the baby will depend on how quickly the court moves to end the parent rights.
