Division Chief (DC) Rick Huffman gave a summary on the Town & Country Fence Co. contract proposal for security purposes around Town Center Fire Station #1. There have been recent vandals, break-ins, fires, trespassing, and damage to the station property.

Director Hawes made a motion and Director Cross seconded for the Board to authorize the Fire Chief to enter into a contract with Town & Country Fence Co. of Oregon for fencing installation at Town Center Fire Station #1 in the amount of \$147,700. The motion passed unanimously.

DC Huffman gave a summary of the request to purchase 24 LifePak-15 Cardiac monitors and one Lucas Chest Compression System for a total of \$1,011,628.89. CFD was awarded a FEMA grant of \$1,000,000 with matching funds to obtain the monitors. A discussion followed.

Director Cross made a motion and Director Hawes seconded for the Board to approve the purchase of twenty-four (24) LifePk-15 Cardiac monitors and one (1) Lucas Chest Compression System for a total of \$1,011,628.89. The motion passed unanimously.

B-6 Request Board Approval of Resolution 23-06 – Resolution concurring with amendment to the Clackamas industrial area urban renewal plan

CFO Whitaker gave a summary of Resolution 23-06 which would transfer Town Center Urban Renewal funds in the amount of \$1.2 million to the Clackamas Industrial Area Urban Renewal plan to make improvements to the District training facility. The County has approved the transfer, but they need concurrence from other tax paying agencies in the area. A discussion followed.

Director Joseph made a motion and Director Cross seconded for the Board to approve Resolution #23-06 to concur on an amendment to the Clackamas Industrial Area Urban Renewal Plan transferring \$1.2 million to assist with renovations and on-site improvements at the Clackamas Fire District's training facility. The motion passed unanimously.

B-7 Request Board Delegation for IT Services Contract

Assistant Chief (AC) Brian Stewart explained that the District has been using a partial IT service for the last 18 years. Due to the loss of personnel in IT, the District has decided to expand these services. Four vendors were considered. The estimated cost of expanded services would be \$350,000-450,000 per year. A discussion followed.

<u>Director Syring made a motion and Director Hawes seconded for the Board to delegate</u> <u>authority to the Fire Chief to negotiate and execute a contract for IT Services. The motion</u> <u>passed unanimously.</u>

AC Stewart gave a summary of what the predictive modeling tool does and how it enhances the data/GIS capabilities for performance reporting, analytics, and distribution studies for the District. - The Health & Safety Division provided onboarding presentations for Sandy career, Sandy volunteer, and apprentice firefighters to include OSHA compliance, health education and wellness benefits.
- During the 2022-2023 school year, Public Education Specialist Tammy Owen taught Hands Only CPR to a total of 3,905 students.
- The Fire District hosted an open house at the Gladstone Fire Station #22. This event was very well attended.
- Carrie Szabo completed her last day as Benefit's Specialist for Clackamas Fire after 20 years of service.
- Job offers and pre-employment screenings were extended to spring and fall entry level academy candidates. Volunteer candidate pre-academy screenings are in process.

 Implementation will be in 2024.


Notable Events/Calls



Hello all,

I wanted to provide you some follow up on a notable cardiac arrest you responded to in late April. This was the teen playing basketball with friends at church who had a community AED placed with bystander CPR.

She was quickly transferred from Kaiser to Doernbecher. Shortly after transfer she was extubated in the PICU and was completely neurologically intact. She did have some trouble with memory initially, but this improved and she has no neuro deficits.

We were able to pull the file from the AED that was used by her friends which helped inform the pediatric cardiologists. We think this AED may have been purchased and installed with CFD Foundation funds.

She underwent a number of tests to determine the etiology of the arrhythmia and ultimately was discharged after an ICD was placed and she was placed on nadolol (a beta blocker similar to or same class as metoprolol).

Of course this is all a testament to the work and training that you do every day. It takes a system that is well prepared and well coordinated, teamwork, and relationships throughout the chain of survival: from community partners, to dispatchers, to EMS, to the hospitals. This is an example of why we do what we do and important to keep in mind when we have those challenging days, because what you do matters.

ODF AND CLACKAMAS FIRE DISTRICT WORK TO TAME THE FOREST PARK FIRE IN BEAVERCREEK.

News Release from Clackamas Fire District

Posted on FlashAlert: June 2nd, 2023 8:40 AM

This morning Clackamas Fire crews met with the Oregon Department of Forestry to hammer out a game plan for the Forest Park fire still burning in Beavercreek. While the 30 acre fire is at 0% containment at this point, hand crews along with some heavy equipment have managed to wrap a fire line about half way around the fire.

The warm, dry weather could pose some difficulty today however, resources are currently making their way to the incident including multiple 10-person hand crews from South Fork, tree fallers, brush rigs and water tenders which are all backed up by a helicopter if deemed necessary.

Clackamas Fire would like to remind those who wish to use drones in the area that doing so will hinder operations as they will have to land the air support for safety reasons. We will post updates as they come in.

On Tuesday, June 27th 2023 at approximately 1:30a.m., Clackamas Fire District Crews responded to a fire alarm at the Wilco Farm Store on Molalla Avenue in Oregon City. Crews arrived to find a smoldering fire in the piles of baled hay and straw next to the warehouse loading area.

Firefighters observed the fire sprinkler system had activated and helped control the fire, and once on scene, firefighters were able to completely extinguish the threat.

Clackamas Fire District investigators, after determining there were no existing sources of ignition, turned to the store manager for video footage caught by the on-site security cameras, which told the entire story. A suspect had gone out of their way to ignite the pile of straw. The suspect remained on scene to watch the flames grow and then disappeared.
