A. Division/Department Reports

R-1a Office of the Fire Chief – Fire Chief Nick Browne

Chief Browne thanked Director Wall for her time, compassion, and dedication in serving the community, firefighters, and staff.

He mentioned the Cultural Awareness Survey and upcoming Board work session on September 26, 2023. Consultants from All American Leadership will be there to discuss the results of the Ethos survey. There were 277 that participated in the survey, and 66 attended the Purpose & Ethos Workshop. He thanked everyone who participated.

The first levy-funded firefighter academy will begin in September. He reported on the August 14th Blue Jay wildfire in Sandy Oregon, and the August 28th Camp Creek wildfire in the Bull Run area of the Forest Service near Sandy Oregon.

He reported that turnout time has decreased, with the fastest time being 1:05 and the slowest turnout time in the last month being 1:44. There was a discussion on the public receiving district information via social media.

R-1b Office of Strategic Services – Assistant Chief Brian Stewart

Assistant Chief (AC) Brian Stewart reported the district was eligible to receive a 10 percent discount from WHA Insurance under their Best Practice Program in 2024. The focus this year was on emergency planning and emergency preparedness.

The fencing project around the administration building has begun. Clackamas County has been meeting on the industrial area urban renewal plan. Additional security cameras will be installed around the district from a grant received.

AC Stewart reported on legislation pertaining to House Bill 2522, which is the rural fire protection district. Beginning September 1, 2023, Fastech assumed all IT services for

CFD. Fastech has one employee on site full-time, and another will be added in the future. He commended all the former IT employees for their hard work.
