### Action Requested

Staff is requesting Board approval to declare the following identified vehicles and apparatus as surplus and to allow the Fire Chief to proceed with disposal.

### Background

These vehicles were purchased in compliance with purchasing policies in place at the time of acquisition and the District has titles to all vehicles and equipment. The FSH trailer was purchased with a matching Fema grant, # EMW-2003-FP-02000. The Mobile Command was partially refurbished back in 2006, due to a fire. Research for purchase of the 2007 Freightliner is ongoing to determine if a grant was originally used, to validate disposal requirements. With the recent acquisition of an additional grant funded USAR trailer and related equipment, this asset as well as the others are no longer used or needed by the District. Estimated values were determined by staff utilizing Kelly Blue Book or NADA as well as outside equipment sales comparisons, however, actual prices will vary based on market conditions at the time of sale.

### Board Policy Implications

The Fire District's Standard Operating Procedure (SOP) on disposal of Equipment requires a description of the equipment, method of purchase, an original acquisition cost, and an estimated fair market value.

### Budget Implications

Additional revenue may be experienced upon the disposal of this equipment. Methods of disposal may include sale or donation to other public agencies where appropriate as determined by the Fire Chief, advertisement to general public via sealed bids, or public auction process. These apparatus and vehicles will be sold as surplus according to District guidelines.





**Recommendation**

Staff recommends Board approval to declare the identified rolling stock as surplus and to allow the Fire Chief to proceed with disposal in accordance with District Policy.

### Action Requested

Staff requests Board approval to spend capital expenditures in the amount of \$1,054,284 to refurbish two (2) 2008 Pierce Type 1 Pumpers and to purchase two (2) new Ford F150 pickups to replace through attrition as well as add capacity with District growth.

### Background

The Fire District owns and operates a fleet of Type 1 pumping apparatus, which are used in various capacities to deliver emergency services to the citizens we serve. Historically, the fire district has replaced pumping apparatus after 20 years, in accordance with the apparatus replacement plan. With the rising costs of new apparatus and the extended timelines that go along with new orders, it is becoming very prudent and cost effective as well as very common to take low hour/low mile, aging apparatus and consider the option of refurbishment. Depending on the scope of the refurbishment, the project can be completed for less than half the cost of a new pumper and can be completed in less than half the wait time. Although apparatus life cycles, replacement planning, and budget approvals are dictated by the fire district, this option also meets several criteria for NFPA to extend the life cycle of the apparatus and allows staff to focus additional spending on other priorities.

Pierce Manufacturing used to perform this type of work, but due to their order backlog, they have shifted this down to their dealers and a newer company they now partially own in Las Vegas, Fire Trucks Unlimited. The district has used this vendor in the past and has had good experiences. The quote for this work to be done was facilitated through them and Hughes Fire as our dealer. The pricing also allows for a little cushion for labor and material increases or anything additional to the current scope.

The requested amount also includes two new pickups. As the district grows and evolves, the staff vehicle needs also change. With the amount of operational response staff and the need to also bolster our wildland presence, both in district and around the state, the pickup model typically meets the needs of everyone much better than a car or an SUV type of vehicle. These pickups can then also be reassigned later as an IMT vehicle for use around



the state or even out of state. When in the IMT use status, these vehicles also serve as additional winter response vehicles that can augment response apparatus or replace heavy apparatus that struggle in certain road conditions and may not be needed on certain calls.

**Board Policy Implications**

Per purchasing policy, Board approval is required for purchases exceeding \$100,000. Any purchases will be made following all Fire District purchasing policies. For the F150 purchases, the District is utilizing a State of Oregon Contract price agreement, per the Districts Special Procurement Policy. Similarly, for the apparatus refurbishments, the District is utilizing the class exemptions for repair, overhaul, and maintenance as outlined in the Special Procurement Policy, allowing the District to move forward without additional bids. The refurbishment work is also highly specialized, so additional bids from other vendors were not available.

**Budget Implications**

The funding for these purchases is identified in the Capital Replacement Fund, 301150-8805 and 8850. In total, the refurbishment expenses, vehicle purchases, and related set up will be within approved FY25 budgeted parameters.

**Recommendation**

Staff recommends the Board of Directors approve the refurbishment expenses of two Pierce Type 1 Pumpers and the purchase of the identified staff vehicles in the amount, not to exceed, \$1,054,284.

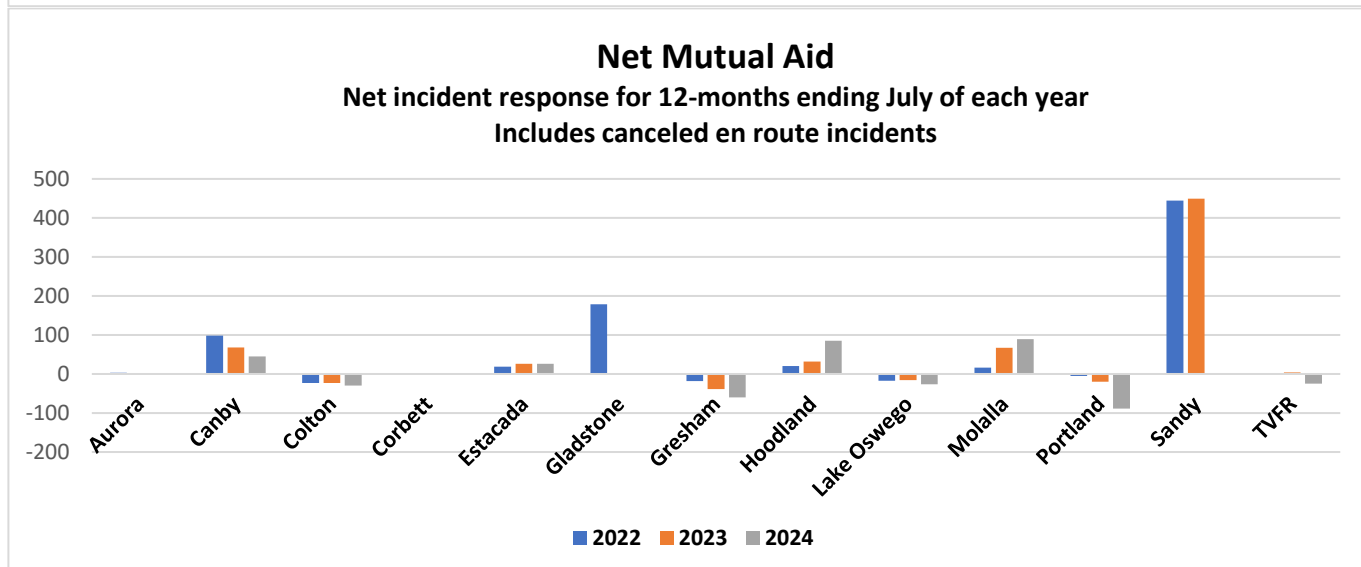
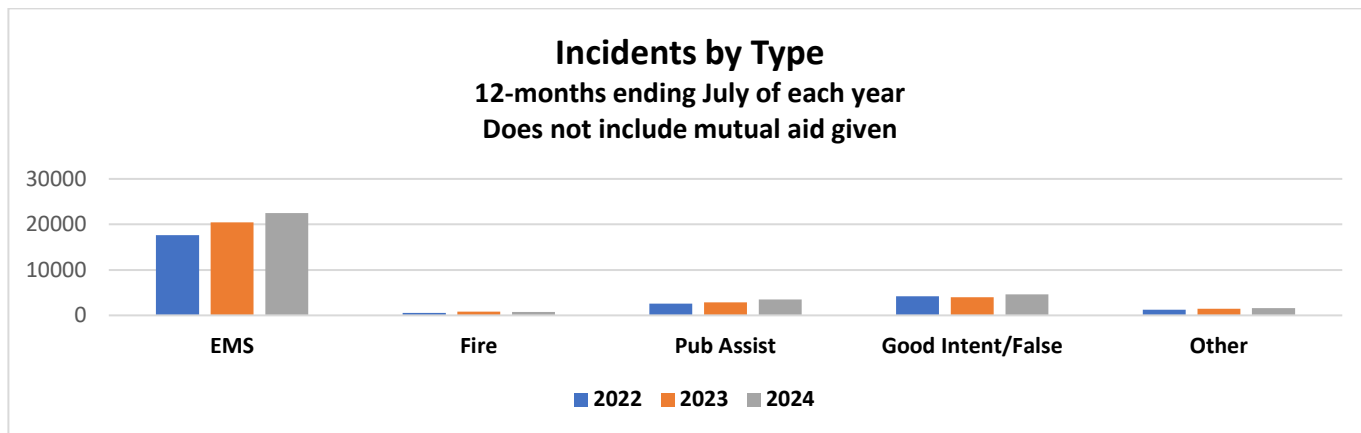
## Notable Calls

**7/6** Motor vehicle entrapment in Molalla Fire District - Mutual aid request with entrapment and multiple patients. T316, HR305 responded for extrication and E313 was dispatched to establish a landing zone for two air ambulances from Life Flight. Five patients were triaged, three being non-critical and both drivers being critical, unconscious, and entrapped. Crews did a great job working with Canby, Colton and Molalla.

**7/11** Holly Lane brush fire – Responding crews saw a large header on the way to a brush fire in a wooded section of Holly Lane. CCOM described explosions and the incident was upgraded to a taskforce. Upon arrival, the brush fire had extended into some fir trees. Day chief and captains responded and assisted with water supply, staging, and drone deployment. Fire under control in 62 minutes. Crews showed excellent critical thinking skills as they worked with limited resources.

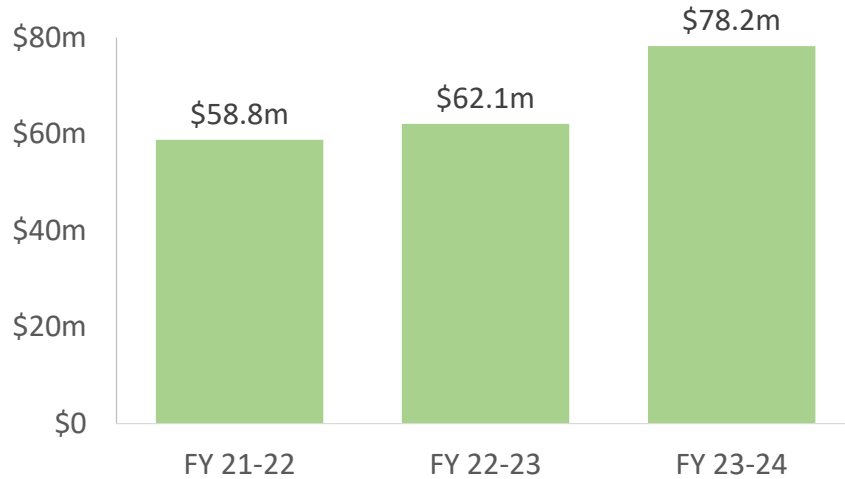

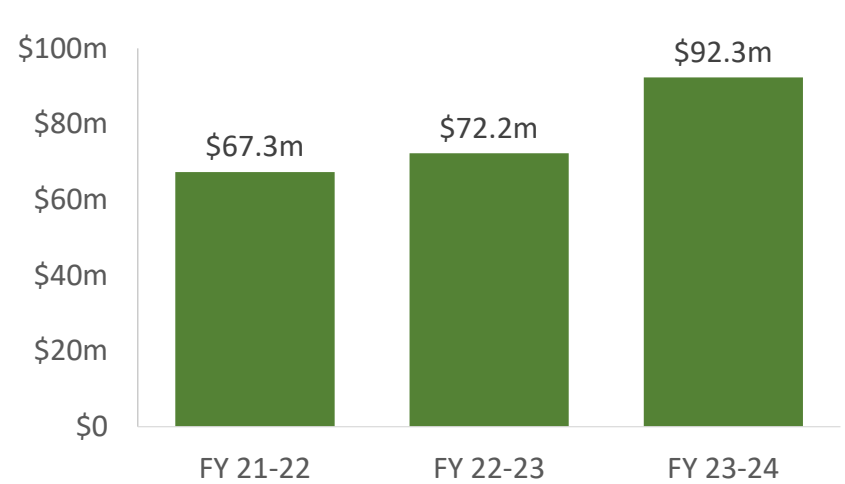
## General Fund Property Tax Revenues

Through June



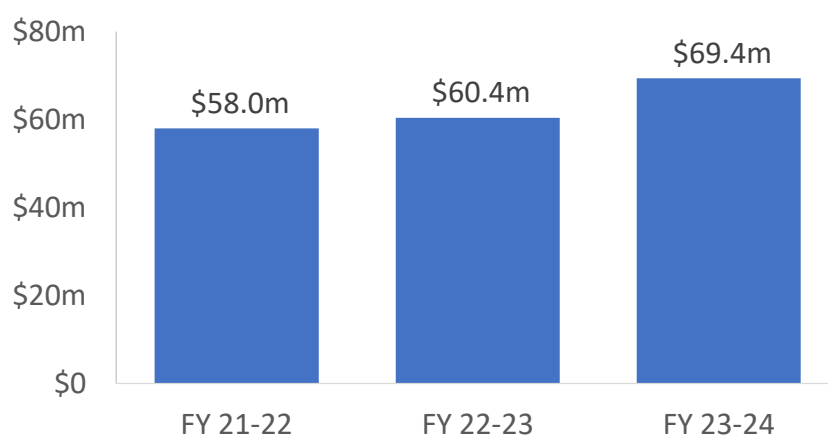
## General Fund Total Revenue

## General Fund Salary & Benefits

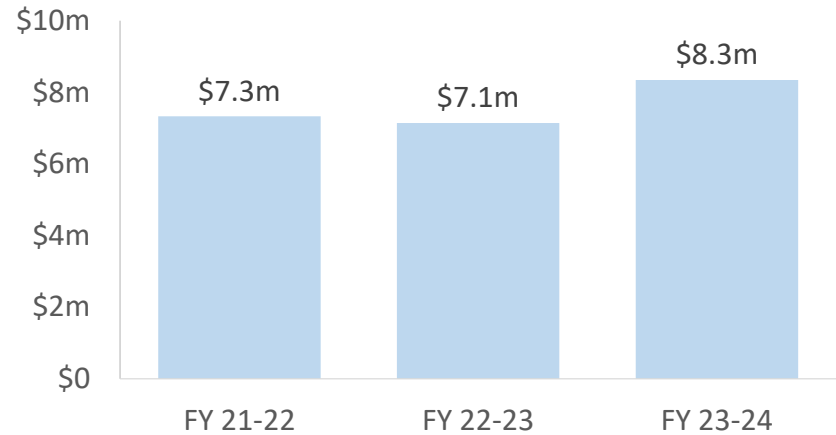

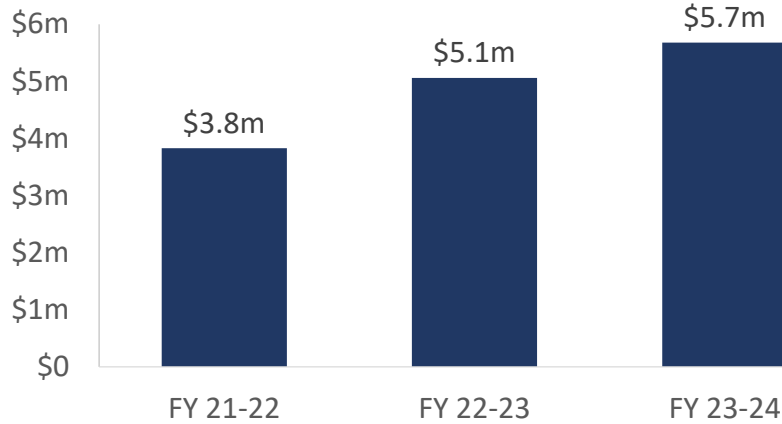

## General Fund Health Claim Expenses

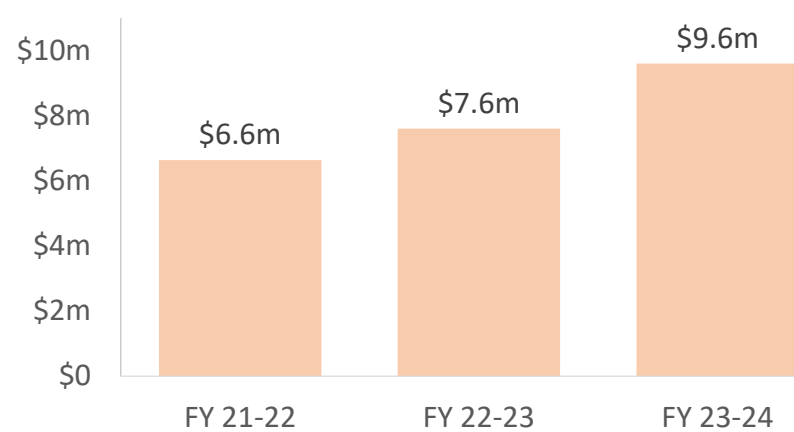

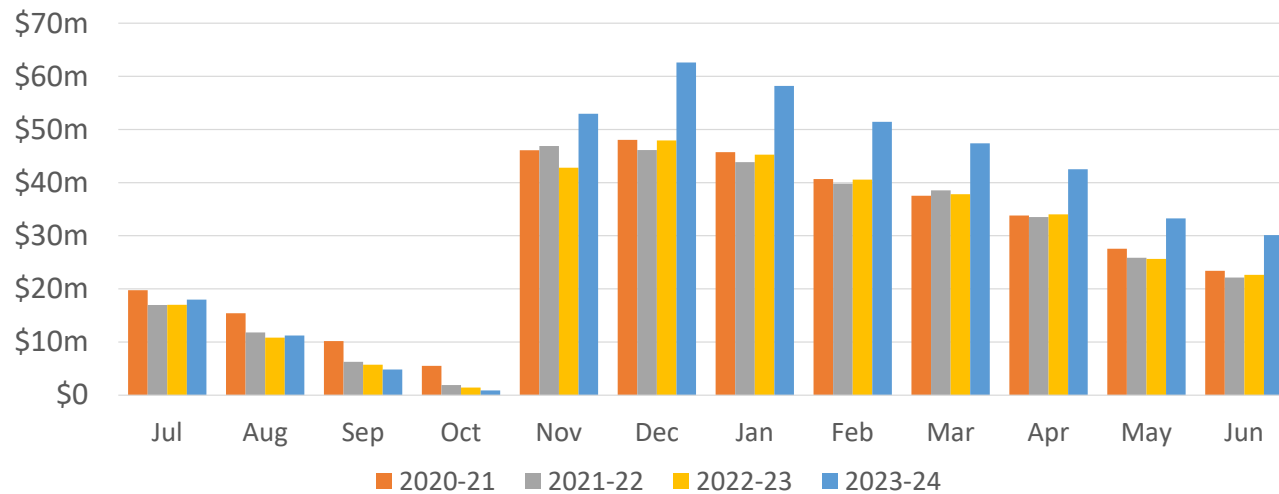
## General Fund Materials and Services
