Clackamas Fire District #1 may reject a bid that does not comply with prescribed public contracting procedures and requirements, including the requirement to demonstrate the bidder's responsibility under ORS 279C.375(3)(b), and that the District may reject for good cause, all bids after finding that doing so is in the public interest. The District reserves the right to waive minor informalities in any bid.
