
## HISTORY OF CLACKAMAS FIRE DISTRICT

Clackamas Fire District #1 formed in 1976 through a merger between the former Milwaukie Fire Protection District #56 and Multnomah County Fire District #12






Clackamas Fire District grows to include territories of Beavercreek Fire District #55, Oak Lodge Fire District #51 and Clarkes Fire District #68



Clackamas Fire District holds successful elections to merge the territories of the Cities of Milwaukie and Oregon City into its district boundaries

The Gladstone Volunteer Fire Department is formally organized following the destruction of the Mayor's house by fire..








An air raid siren is purchased to alert firefighters to emergencies, and over the years, improvements like fire hoses, pumps, and motorized vehicles were made.




A new City Hall is built, housing the fire station and emergency dispatch center, a location the department still occupies today.





Over the next few decades, firefighters transition from volunteers to paid "on-call" staff over time, with stipends and wages introduced.



## WHAT ARE THE BENEFITS OF ANNEXATION?



Gladstone Fire, as a smaller fire department, had struggled to recruit and maintain full time, trained personnel. Prior to contracting with Clackamas Fire, Gladstone had relied on both hired staff and volunteers to respond to emergencies.



Annexation would provide Gladstone residents the opportunity to receive all Clackamas Fire services without having to face contract renewals.


Gladstone voters would be able to have more control, more stability, and more say in how their property tax dollars are allocated.

## WHAT WOULD ANNEXATION **COST?**



Gladstone residents would pay the same base amount as those who live within Clackamas Fire boundaries, which is \$2.40 per \$1,000 of assessed property value




Annexation of Gladstone into Clackamas Fire would see an estimated increase of less than \$7.50 per month for the average Gladstone homeowner

Gladstone residents would have the opportunity to vote on any future funding measures






